MANAGER'S COMMENTS

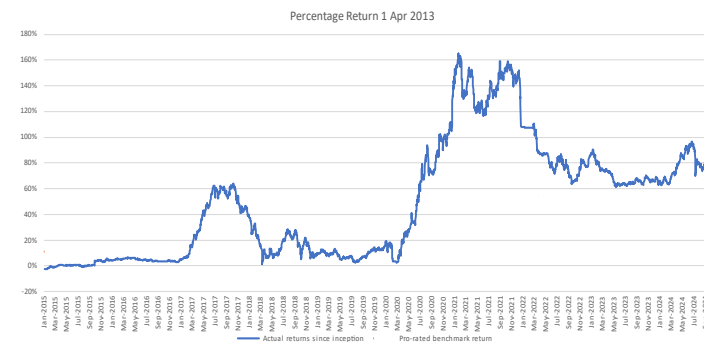
The KLCI fell by 2.9% month-on-month in October, closing at 1,602. This decline was driven by concerns over tax expansion announced in Budget 2025 and heightened uncertainty surrounding the U.S. election. Sectors experiencing losses included Utilities, Telecommunication, and Consumer Services, while Construction, Healthcare, and REITs posted gains. Market breadth was heavily negative, reflecting widespread profit-taking across the board.

The Utilities sector experienced downward pressure due to Malaysian Anti Corruption Commission probe into YTL Communications, a subsidiary of YTL Power. In contrast, the Healthcare sector benefited from higher U.S. tariffs on Chinese glove producers and a strong rebound in the ringgit. The Construction sector saw healthy bargain hunting, while REITs gained, supported by improved earnings guidance from Pavilion REIT and Sunway REIT.
